

## ANNUAL TAX LEVY ORDINANCE

AN ORDINANCE for the levy and assessment of a tax for corporate purposes for the Bristol-Kendall Fire Protection District, a body corporate, in the County of Kendall, State of Illinois, for this fiscal year beginning May 1, 2016 and ending April 30, 2017.

BE IT ORDAINED by the Board of Trustees of the Bristol-Kendall Fire Protection District:

Section 1 - That there be and there is hereby levied and assessed for corporate purposes for the Bristol-Kendall Fire Protection District of Kendall County, Illinois, for the fiscal year beginning May 1, 2016, and ending April 30, 2017, the total sum of Five Million Six Hundred Eighty Six Thousand One Hundred Ninety Four Dollars and Zero Cents (\$5,686,194.00) upon all property subject to taxation within the said Fire Protection District boundaries as the same is assessed and equalized for State and County purposes for the current year; said sum so levied being for the following corporate purposes for the fiscal year beginning May 1, 2016 and ending April 30, 2017, as ascertained and set forth in the Certificate of Needs of the Bristol-Kendall Fire Protection District as passed and approved by the Board of Trustees, of the Fire Protection District as required by law.

Section 2 - That said tax so levied and assessed as aforesaid be collected and enforced in the same manner and by the same officers as the State and County Taxes and be paid over by the officers so collecting the same to the proper officer of the said Bristol-Kendall Fire Protection District as provided by law.

Section 3 - That the secretary of said Fire Protection District forthwith make and file with the County Clerk of Kendall County, Illinois, a certified copy of this Ordinance and that the rate percent be ascertained and the tax extended as provided by law.

Section 4 - That this Ordinance shall take effect and be in full force from the date after its passage and approval.




