Mission Statement

The mission of the Bristol Kendall Fire Protection District Cadet Program is to develop responsible, skilled, and community-minded individuals by providing hands-on training, education, and mentorship in the fire service. Through teamwork, discipline, and service, the program prepares cadets for future careers in emergency services while fostering leadership, integrity, and a commitment to public safety.

Pre-Hire Requirements

Applicants must meet the following requirements at the time of hire:

- Successfully complete an oral interview.
- Be between 18 and 25 years of age.
- Possess a valid State of Illinois driver's license.
- Reside within 75 miles of the Bristol Kendall Fire Protection District.
- Complete and submit Bristol Kendall Fire Protection District Cadet Application.
- Successfully pass a background check.
- Have no felony or disqualifying misdemeanor convictions.
- Be a U.S. citizen.
- Successfully pass a district provided physical examination.

Training

Cadets are required to successfully complete all program training components, including:

- Weekly educational assignments through the District's Learning Management System (LMS).
- Weekly quizzes.
- All final exams.
- Mandatory attendance and participation in all hands-on practical training sessions held on Fridays.
- Completion of all required monthly ride time hours.
- Successful completion of all OSFM BOF and Hazmat Operations exams.

All required safety gear and uniforms will be provided by the District.

Program Timelines

- **Application Deadline:** February 20, 2026, by 1600 hours
- **Oral Interviews:** Weeks of March 9 and March 16, 2026
- **Initial Eligibility List Established:** Week of March 30, 2026
- **Trustee Board Approval to Hire:** April 9, 2026
- **Pre-Employment Physical Examinations:** Mid-April through May 2026
- **Orientation:** May 29, 2026
- **Class begins:** June 1, 2026 - October 30, 2026
